



## Tennessee Capitol: Back in Action

Renovations to the Tennessee State Capitol in Nashville are over, and the 44<sup>th</sup> Tennessee Intercollegiate State Legislature General Assembly is calling the Capitol "headquarters" once more.

The building was closed for six months starting in May of 2012 for a 15.7 million dollar renovation. This renovation included exposing historical vaults, upgrading technology, enhancing security and replacing carpets.

This year the TISL General Assembly will be held at the Capitol and many members are excited to see the grandeur and tech savvy renovation work.

TISL Secretary of State Jamie Arnett says, "Being back in the Capitol for the General Assembly will be a treat for everyone. The improved Wi-Fi and extra outlets will allow us to work more efficiently."

#### **Delegates Receive Guidance at Workshops**

TISL delegates had the opportunity to attend five workshops in October to prepare for the 44th General Assembly.

Various members of the state Executive Council led each workshop, where the delegates had the opportunity to learn about the main components of TISL within two breakout sessions.

At the Jackson workshop, Clerk & Marshall of the Supreme Court Caleb Butler spoke about the functions and processes of AMC3. Butler also spoke about the hearing itself, including the limits for arguments.

This year's case is Waddams v Initech Industries Inc., which deals with reverse discrimination.

The other first breakout option was Researching and Writing a Bill. Speaker Pro Tem. of the Senate John



Domanski spoke to the Jackson workshop delegates about how to effectively write a bill.

Domanski said that the key to writing a good bill is in the research.

Other breakouts included a session on Lobbying. Professional lobbyists will serve as the clients for the lobbying firms.

Each lobbying firm has a CEO who will guide the direction for the team. Some good techniques for lobbying include developing influence with voting members and finding legislators who agree with the firm's stance.
